#### **Purpose**

#### **Preamble**

Enclosed is the nomination package for CTCC's Annual Entrepreneurship Awards Gala for 2020. These awards are presented to recognize the outstanding achievements and contributions by the Tamil Canadian business community. The nomination form is designed to gather information necessary for the Awards selection committee with appropriate facts to facilitate the selection process. Information provided for each of the criteria should pertain to the contributions and achievements in Canada except for the academic and professional designations for the Most Outstanding Professional /Academic Award. All nominees are encouraged to provide additional information in an attachment where appropriate. It is the responsibility of the nominee and nominator to ensure that all information submitted is accurate to the best of his/her knowledge. It is the responsibility of each applicant to ensure that all requested material is submitted in full and on time. Failure to do so will result in disqualification without notification.

The nomination package should be submitted to the Chamber on or before the specified deadline of **February 24th 2020 5PM**. All information listed in your nomination form will be used only for nomination committee purposes. Please note, that only award winners selected by the committee will be contacted.

#### **Method of Selection**

The Award Selection Committee, appointed by the Board, will be responsible for the selection of the winners for these awards. The Award Selection Committee will consist of three members of the CTCC. The Award Selection Committee will review the nomination package and supporting documentation, visit the business organizations and interview the nominees as appropriate in order to select the winners. The Award Selection Committee reserves the right to request additional information, relating to the nominee, if necessary. The Award Selection Committee, if it deems appropriate, may recommend that an award may not be presented when there are no qualified candidates.

Letters sent either by post to CTCC office or by email should be marked "Gala Awards Nomination Package, private & confidential" and received at CTCC office by email or on or before February 24th, 2020 5:00 p.m.
